

- (c) Veterinary medicine includes veterinary surgery, obstetrics, dentistry and all other branches or specialties of veterinary medicine.

Dr. Larry Hazen, Chair of Allied Health Board of Examiners

Chairman called the public hearing to order. He welcomed the Senators present. Chairman Mike Cruz read the purpose of the bill and asked if anyone was present to testify on behalf of the bill.

RT - GAIN Board Treasurer. Supports 270. Was present at the first Allied Health Board reviewing the R&R for spay/neuter clinic. At the time, he was President of GAIN. Strongly believe that clinics are very good for the community. It is also a very good educational tool. I see animals every year coming in not being able to get surgery - tumor. Happened because of the clinic. People don't understand the importance of vaccines. Education is very important. They are given a list of vets on island. GAIN recommends vets on Guam. Only problem is I question the need to say 8 days. Full support of the bill and it supports GAIN.

**BL** – In favor of the bill. Volunteers in all clinics on island. Feels there should not be any restrictions. It would help overpopulation on Guam. Right now there's 110 animals in the shelter. Intake is 3,000+ at GAIN, 600+ were adopted, the rest were euthanized. A certified euthanasia technician.

**Hazen** – have no problem with animal control, spay/neuter clinic. Problem is allowing people to practice on Guam, when not licensed on Guam. Similar to physicians, in the past, orthopedic doctors. This bill sets poor precedence for licensure on Guam. Licensure is to protect the public. If spay/neuter is to control population, then it should do just that.

This bill is poorly written. The Guam Board of Law has nothing to do with spay and neuter.

Veterinary technicians - no licensing

I encourage this committee to not pass this bill the way it is proposed, revisit these weaknesses, and hold a future hearing before putting it on the floor for a vote.

CC- thank you Dr. Hazen. Karen before you go forward. Dr. Hazen, there are physicians that practice on Guam that don't have licenses here, is that not true?

Hazen- not that I'm aware of.

CC- the Shriner's doctors that visit have no licenses on Guam, are they able to perform and see patients?

Hazen- yes, with a temporary license.

KJ – Vice President of GAIN. 2 years ago. Allied Health Board does not have the authority to grant temporary licenses to veterinarians. If volunteer veterinarians have to be licensed on Guam then we would not be able to do these clinics. If this bill does not go through I will not be unhappy that we made a commitment to the attorney for the Board if this bill does not go through then it'll leave us free in court to litigate the meeting of animal control under the present statute. If this bill does not go through then we will be back in court. I see nothing about authority to issue temporary licenses in the statute.

**Hazen** – The Governor has the authority to issue temporary licenses.

Marie Chenery – President of GAIN. Shriners Hospital I was surprised to hear Dr. Hazen's testimony. In October 2005, they came to an agreement. The clinics have not changed from how it was before. This type of clinic is not new. Bureau Area Veterinary Services is the group that got us started with these. BAVS came out for 3 years.

CC- Thank you.

Janet Cruz – Acting Administrator – Temporary license, Shriners. Board of Medical Examiners does issue a 90-day temporary license on Guam. It is up to the individual to get full Guam licensure. There are certain requirements for the licenses. Purpose for the Board is to protect the community. P.L. 24-325 eliminated temporary license.

**Dr. Harper** – Veterinarian & member of Allied Health Board. Surprised that the clinic is more than once a year. The Board has always felt that these clinics are needed and very necessary. We are very concerned that the services provided are beyond animal control and they're attempting to fall under the animal control exemption clause for licensure, which is what was acknowledged.

K - do our veterinarians have the same reciprocity when we go to the states?

JC- no too sure.

K- do we do any survey to check whether they have been neutered?

JC- the ones that are brought in, which are stray animals, are not.

K- how many are treated during an 8-day clinic?

**J.C.** – anywhere 200-600 sterilization procedures at the 8-day clinic.

CC- Is any license from the Philippines able to get a license to practice permanently here on Guam?

Dr. Diaz- not too sure. I believe any foreign graduate should have a U.S. license.

**Brown** – what impact would it have on the number of doctor's you'd be able to have come and participate in the clinics if it was simply limited to the U.S.?

JC- if it was U.S. license veterinarians only, I believe it would be okay.

CC- Dr. Harper, I'm interested in the issue that you cannot apply from veterinarian medical school and graduate with a veterinarian degree and not be able to come to Guam and get a license from Guam. If you don't have a license from other states you cannot get one on Guam.

Chairman - Seeing no more testimonies on Bill 270 (EC) Chairman Cruz adjourned.

### COMMITTEE RECOMMENDATION:

The Committee on Health & Human Services recommends that Bill 270(EC), "An Act to repeal and re-enact Section 121903(c) of Article 19, Chapter 12, Title 10 GCA, relative to the Creating Exceptions Licensure Requirements for Volunteer Veterinarians" be submitted to I Mina'Bente Ocho Na Liheslaturan Guåhan with a recommendation TO PASS Bill No. 270(EC).

I was president of GAIN in 2000 when we began these clinics. I accompanied Marie Chenery when she went before GBAHE to request that they define spaying, neutering, and ancillary services including vaccines as part of animal control. I have read all the correspondence since then where GBAHE again recognized these procedures as part of animal control, or in later years failed to respond to GAIN's notice of Clinic dates.

As the GAIN President, I personally visited every civilian veterinarian on island to invite them to participate, both in 2000 and in 2001. While the only civilian veterinarian to consistently volunteer has been Dr. Rebecca Diaz, none of the veterinarians spoke against the idea. Their reasons for not participating centered around the need to keep their own clinic open, not around the idea of GAIN having these clinics.

I strongly believe these clinics to be a great service to the residents of Guam. Not only have they taken thousands of animals out of the breeding pool, but they are a way to educate people as to the realities of responsible pet care. Each year I see people who have never before considered taking their dog or cat to a vet come through the door. By the time they leave, they have a much healthier animal, and a better understanding of their responsibilities as a pet owner. While not everyone will return to a vet, many do. In addition, many now learn to buy Heartgard, Frontline, or other such supplies from the nearest vet clinic to keep their pet healthy. An added benefit is that people spread the word, telling their friends and relatives about the joys of having a healthy pet that is not continually having babies.

Every year there are animals that are simply in too poor shape to have surgery. The care and medications provided by the visiting vets and GAIN, along with the education, show them that their pet can be healthy. They are given if necessary, a "rain check" to have the surgery later when the animal is healthy. (Dr. Rebecca Diaz graciously does those surgeries.) Other animals do have surgeries, but go home with needed medications.

I question only one thing about Bill No. 270, and that is the section limiting these projects to 8 days. While it would be a rarity to have any one project go longer than that, the artificial limit could be a problem if in any one year there is a reason to extend. An example might be a visiting vet staying on to help out with the "rain checks".

I strongly urge all senators to support this bill, and through that support to show their support for these very worthwhile clinics.

### Dear Honorable Senators:

This testimony is being submitted to support the passage of legislation (Bill 270) that is being introduced by Senator Brown.

Both sets of legislation allow for the continued annual sterilization clinics that are sponsored by Guam Animals In Need.

As a participant during the past six years of sterilization clinics, I firmly believe that this service is needed on Guam. The clinics are designed to allow licensed off-island veterinarians to visit Guam, sterilize pets and provide minimal services that allow for the continued health of the pet sterilized. These services do and should continue to include the sterilization procedure, parasite control, and vaccination for rabies plus viral diseases common to tropical areas.

Each clinic reaches clients that have never visited a veterinarian as well as people who attempt to assist the animal control procedure by bringing their neighbor's pets for services. The argument may be made that some of the people using the clinic can and should afford veterinary care at the prevailing local prices. However, the reality is that they do not choose to do so and will allow their pets to continue reproducing, which places a heavy emotional and financial burden on the community.

I would also like to speak in favor of continuing vaccination and parasite control at these clinics. All of the veterinarians present rotate through a check-out process that includes client education regarding the need for regular veterinary care, vaccination plus internal and external parasite control. It would make no sense to sterilize a pet then allow it to die from parasites or viral diseases. That process would only impress the client that there is no point in the sterilization process. The thought process might be the pet is going to die anyway.

Providing the current scope of services combined with continued efforts to educate each and every participant that utilizes the sterilization clinic can only lead to an increase in the number of animals sterilized and improvement in the level of care that each pet will receive during it's lifetime.

The one addition that I think would be prudent to add is a small budget to provide classroom materials and possibly a subsistence per diem to induce an in-class lecturer to visit our elementary schools and begin planting the seed of responsible pet guardianship to our younger generation. EDUCATION is the key!!!

Testimony concerning Bill 270, An Act to Repeal and Re-Enact Section 121903(c) of Article 19, of Chapter 12, of Title 10, Guam Code Annotated Relative to Creating Exceptions to Licensure Requirements for Volunteer Veterinarians.

Dear Senators,

Thank you for the opportunity to testify in favor of this measure. Guam Animals In Need, Inc., has sponsored low-cost sterilization programs for several years, using, in part, off-island veterinarians who donate their time to this program. For several years, these veterinarians were not required to be licensed on Guam, under the exception provided by Title 10, GCA, Section 121903(c), which exempts from licensure those practicing animal control. In 2004, however, GAIN was advised by the Guam Board of Allied Health Examiners that it was re-interpreting the law to require that these volunteer veterinarians hold Guam licenses if they were to practice at GAIN's low-cost clinics. When the issue could not be resolved, GAIN filed a complaint in the Superior Court of Guam, and obtained a temporary restraining order which allowed it to hold its 2005 clinic. Since then, counsel for GAIN and the Attorney General's office arrived at a resolution of this issue which was believed to satisfy the need for low-cost animal control measures and the proper concerns of the Board that persons practicing veterinarian medicine on Guam be qualified in their field.

GAIN believes it is essential that "animal control" include all vaccinations, and not be limited strictly to rabies. The three prongs of a successful animal control program are legislation, education and sterilization. Offering full vaccines for the animals brought to the sterilization clinics is an important way of educating the owners. By learning how to properly protect their animals from diseases and parasites, owners take more interest in their animals.

The International City/County Management Association has published a comprehensive guide for local governments entitled Animal Control Management. The book devotes an entire chapter to programs for spaying and neutering. It notes that hundreds of communities have offered government-subsidized clinics and IGINAL

programs, which have had a marked impact on animal populations. Reduced-rate vaccinations are one of the services routinely offered by such programs.

The goal of these clinics is to reduce the stray animal population, which constitutes a threat to public health and safety, and to encourage responsible pet care by promoting the animal's general health, of which vaccinations are an important part. The same people who cannot afford to sterilize their pets, cannot afford to vaccinate them.

1/Footnotes: §121903 (C), Chapter 12 of 10 GCA provides that a person advising or performing acts which the Guam Board of Allied Health Examiners or Guam law recognizes as accepted animal control practice, is exempt from licensure requirements. Additionally, as early as year 2000 "spaying and neutering" has been recognized by the Board as an accepted animal control procedure. Bill 270(EC) proposes to incorporate such intent into statute, as it defines "animal control" practice as inclusive of, but not limited to animal health and population control programs subject to the conditions specified in the Bill language. The fiscal impact is anticipated to be positive as it is designed to reduce costs connected to stray animals on Guam.
